Introduction to the association and its web-site

The Property Bar Association was formed on 23 November 2000 at the instigation of practising members of the Bar, with the support of Mr Justice Neuberger (as he then was). It is the professional body for barristers in England and Wales who are able to certify in writing that not less than half of the matters that they deal with concern property or property-related work. It is therefore a body of specialists who are expert in property law.

Its main objects were, and remain:

- to give voice to the opinions of specialist property lawyers on questions of law reform and changes in practice;
- to provide a pool of expertise and a forum for discussion, education and training;
- to raise the profile of property barristers as a body of persons perceived as specialising in property law; and
- to develop innovative services to lay and professional clients.

The association has been accredited by the Bar Council for the purposes of continuing professional development including its New Practitioners' Programme. It has also been accredited by the Law Society and the Royal Institute of Chartered Surveyors for similar purposes.

The association has a programme of meetings, lectures and seminars. Details of these can be found on the Events page of the association's website, www.propertybar.org.uk. The website was established in 2001 and is currently in the process of being updated.
